



- **D.** Condemnation. The proceeds of any award or claim for damages, direct or consequential, payable to Mortgagor/Grantor in connection with any condemnation or other taking of all or any part of the Property or the common areas and facilities of the PUD, or for any conveyance in lieu of condemnation, are hereby assigned and shall be paid to Lender. Any amounts disbursed by Lender under this paragraph F shall become additional debt of Mortgagor/Grantor secured by the Security Instrument. Unless Mortgagor/Grantor and Lender agree to other terms of payment, these amounts shall been interest from the date of disbursement at the Note rate and shall be payable, with interest, upon notice from Lender to Mortgagor/Grantor requesting payment.
