The Agreement provides in posit that Owner leases to Sprint certain real property owned by Owner and located at 4225 N. Sheridan, City of Chicago, County of Cook, Swit of Illinois, together with non-exclusive easements for reasonable access thereto, for placement of an underground grounding system, and for access to the appropriate source of electric and telephone facilities (the "Site"). The Site is further described in Exhibit A attached hereto. The term of the Agreement is 5 years commencing on November 9, 2004, which term will automatically renew for four additional terms, (each a "Renewal Term") of 5 years each, which services Sprint provides Owner with notice of its intention not to renew no less than 90 days prior to the expiration of the Initial Term or any Renewal Term.




