FINAL JUDGMENT ORDER

This matter coming on to be heard on the complaint of the GRAND AVENUE RAILROAD RELOCATION AUTHORITY to ascertain the just compensation for taking the property sought to be taken for the purpose of constructing a railroad grade crossing, as more fully set forth in the complaint; the Plaintiff by its attorney Richard J. Ramello of Storino, Ramello & Durkin;

Due notice of this hearing having been given, the Court having heard and considered the stipulations and the representations of counsel;

NOW, THEREFORE, this Court finds that.

- All of the Defendants have been served with process as provided by statute. The Defendant, WAYNE P. FILOSA, filed an appearance by his attorney, Michael D. Leroy, of the law firm of Neal, Murdock and Leroy, LLC. The Defendant, MARIA PAPAS, Cook County Treasurer and Ex Officio Cook County Collector filed an appearance by its attorney William Motto, Assistant State's Attorney on behalf of the Honorable Richard A. Devine, State's Attorney of Cook County. The Court having jurisdiction of this proceeding and of all parties;
- 2. That Motion for the Immediate Vesting of Title in Parcel OF90093 and OF90093TE, both that are legally described in Exhibit "A" attached hereto and incorporated herein by reference, was heretofore file and presented by the Plaintiff. On February 24, 2004, the court found and entered an order fixing preliminary just compensation in this matter in the amount of FORTY-NINE THOUSAND ONE HUNDRED TWENTY DOLLARS (\$49,120.00) and made certain additional findings as required by law.
- 3. That on March 17, 2004 the Grand Avenue Railroad Relocation Authority deposited with the Cook County Treasurer the sum of FORTY-NINE THOUSAND ONE HUNDRED TWENTY DOLLARS (\$49,120.00) as preliminary just compensation for the taking of Parcel OF90093 and the temporary construction easement (not to exceed three years) of Parcel OF90093TE.
- 4. That on March 24, 2004 the court entered an order that the Plaintiff be vested with fee simple title to Parcel OF90093 and a temporary construction easement (not to exceed three years) to Parcel OF90093TE, and did authorize the Plaintiff to take possession thereof.

FINAL JUDGMENT ORDER

- 5. That the sum of TORTY-NINE THOUSAND ONE HUNDRED TWENTY DOLLARS (\$49,120.00) has been stipulated to be just compensation in full to be paid by the Plaintiff for the fee simple title to Faccel OF90093 and a temporary construction easement (not to exceed three years) to Parcel OF90093 E. The agreed amount includes any claims for interest due from the Plaintiff to the Defendants.
- 6. The owner and interested parties to Parcels OF90093 and OF90093TE, which are legally described in Exhibit "A" which is attached receip and incorporated by references are:
 - A. Defendant, WAYNE P. FILOSA; and
 - B. Defendant, MARIA PAPPAS, Cook County Treasurer and Ex Officio Cook County Collector

Said parties are entitled to receive the sum of FORTY-NINE THOUSAND ONE HUNDRED TWENTY DOLLARS (\$49,120.00) as full and final just compensation for the fee simple title to Parcel OF90093 and a temporary construction easement (not to exceed three years) to Parcel OF90093TE. No other party has a compensable interest in Parcel OF90093 or Parcel OF90093TE.

7. The parties have waived the right to the impaneling of a jury for the viewing of the premises and for the determination of just compensation.

IT IS HEREBY ORDERED THAT:

1. Just compensation to the owner and interested parties for the taking of Parcel OF90093 and the temporary construction easement (not to exceed three years) to Parcel OF90093TE is FORTY-NINE THOUSAND ONE HUNDRED TWENTY DOLLARS (\$49,120.00) and judgment is hereby entered in that amount. The agreed amount includes any claims for interest due from the Plaintiff to the Defendants.

That the judgment entered herein in the amount of FORTY-NINE THOUSAND ONE HUNDRED TWENTY DOLLARS (\$49,120.00), as full and just compensation for Parcel OF90093 and OF90093TE, be and the same is hereby declared satisfied and the judgment entered herein against the Plaintiff is hereby released.


