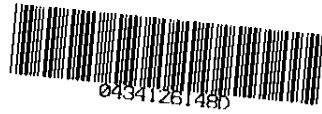

Code of Chicago.



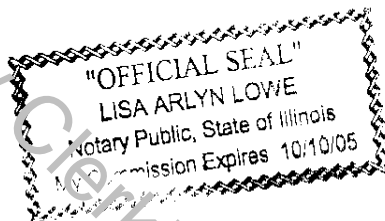
