AN ENDMENT NO. 1 TO MORTGAGE AND SECURITY AGREEMENT – LASALLE BANK NATIONAL ASSOCIATION TRUST NO. 106784

Amendment No. 1 to Mortgage and Security Agreement dated as of May 21, 2004, made by LASALLE BANK NATIONAL ASSOCIATION f/k/a LASALLE NATIONAL BANK, not individually, but solely as Trustee under that certain Trust Agreement dated August 8, 1983 and known as Trust No. 106784 ("Mortgagor") in favor of LASALLE BANK NATIONAL ASSOCIATION f/k/a LASALLE BANK NI ("Mortgagee"). This Amendment pertains to the real estate described on Exhibit A attached hereto and made a part hereof.

PREAMBLE:

Mortgagor gave to Mortgagee that certain Mortgage and Security Agreemen dated May 20, 1997, which was recorded on May 21, 1997 in the Office of the Cook County, Illinois Recorder of Deeds as Document No. 97-362791 (the "Mortgagee"). Mortgagor has requested Mortgagee to modify certain terms and provisions of Mortgagee's financing of Mortgagor. Mortgagee has agreed to do so, so long as, among other things, Mortgagor executes and delivers to Mortgagee this Amendment.

NOW, THEREFORE, in consideration of the premises which are incorporated herein by this reference and constitute an integral part hereof and the execution and delivery of this Amendment, Mortgagor agrees as follows:

1. Section 1.01 of the Mortgage is amended to read as follows:

"1.01 Note. Pursuant to that certain Loan and Security Agreement dated May 20, 1997, as amended from time to time, including, but not limited to, as of the date of Amendment No. 1 to this Mortgage entered into by and among Mortgagee, the beneficiary of Mortgagor (said beneficiary shall be referred to as the "Beneficiary") and Mortgagor (said Loan and Security Agreement, as amended, and as may be further amended or restated from time to time, shall be hereinafter referred to as the "Loan Agreement"), that certain Promissory Note dated May 20, 1997, as amended from time to time, including, but not limited to, as of the date of Amendment No. 1 to this Mortgage

(said Promissory Note, as amended, and as may from time to time be further amended, modified, substituted, restated, renewed and/or extended, shall hereinafter be referred to as the "Note") in the principal amount of \$1,250,000.00 payable, along with interest, and maturing as specified in the Promissory Note has been or is being contemporaneously executed and delivered by Beneficiary and Mortgagor to Mortgagee."

- 2. All references to the "Mortgage" in the Mortgage shall mean the "Mortgage" as amended by this Amendment and as may be further amended and/or restated from time to time.
- 3. In all other respects, the Mortgage is hereby restated, reaffirmed and incorporated herein, the only amendments intended to be made thereto being those above set forth. Except as specifically set forth herein to the contrary, all terms defined in the Mortgage shall have the same meanings herein as therein.
- Exculpation. This Amendment is executed by Mortgagor, not personally but as trustee as aforesaid, in the exercise of the power and authority conferred and fixed in its as such trustee, and it is expressly understood and agreed that nothing herein contained shall be constituted as creating any liability on Mortgagor as trustee as aforesaid, or an Mortgagor personally, to pay the Obligations or any interest that may accrue thereon, or any indebtedness accruing hereunder, or to perform any covenant either express or implied herein contained, all such liability on Mortgagor, if any, being expressly waived by Mortgagee and by every person now or hereafter claiming any right or security hereunder. Each and all of the representations, warranties, covenants, undertakings and agreements made by the Mortgagor as trustee as aforesaid are made for the purpose of binding (and shall be enforceable against) the Beneficiary and its, his, her and/or their successors and assigns. So far as Mortgagor as trustee as aforesaid, and its successors, and the Mortgagor, personally, are concerned, Mortgagee and the holder or holders of the Note and the owner or owners of the indebtedness accruing hereunder shall look solely to the property hereby conveyed for the payment thereof, by he enforcement of the lien hereby created, in the manner herein and in the Note provided, or by action to enforce the personal liability of any Guarantor or co-maker.
