(g) PRIOR MORTGAGE: If the provisions of this paragraph are completed, this Mortgage is subject and subordinate to a prior mortgage dated 11/12/2004 and given by us to CHL ,

Borrower shall give Lender prompt notice of any lapse in required property insurance coverage provided by the master or blanket policy.

In the event of a distribution of property insurance proceeds in lieu of restoration or repair following a loss of the Property, or to common areas and facilities of the PUD, any proceeds payable to Borrower are hercon assigned and shall be paid to Lender.
