1. Payment of Principal, Interest, Escrow Items, Prepayment Charges, and Late Charges. Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. shall continue to pay to Lender the amount of the separately designated payments that were due when the insurance coverage ceased to be in effect. 


