What Lender requires as a condition of this waiver can change during the term of the

Borrower shall give Lender prompt notice of any lapse in required property insurance coverage provided by the master or blanket policy.

In the event of a distribution of property insurance proceeds in lieu of restoration or repair following a loss to the Property, whether to the unit or to common elements, any proceeds payable to Borrower are hereby assigned and shall be paid to Lender for application to the sums secured by the Security Instrument, whether or not then due, with the excess, if arly, paid to Borrower.

. Public Liability Insurance. Borrower shall take such actions as may be reasonable to insure to at the Owners Association maintains a public liability insurance policy acceptable in form, emrant, and extent of coverage to Lender.

D. Cordemnation. Unless Borrower and Lender agree to other terms of payment, these amounts shall beal interest from the date of disbursement at the Note rate and shall be payable, with interest, i pon notice from Lender to Borrower requesting payment.
