

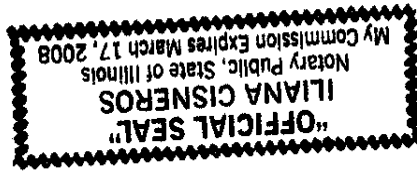
Permanent Tax Number, 29-17-320-031-032,

On November 15, 2004, Claimant completed delivery of all required materials needed by said contract.

That said Contractor is entitled to credits on account thereof as follows: thirty-six thousand dollars for material, labor, profit and overhead and seven thousand dollars is due Claimant. Leaving due, and unpaid and owing Claimant, after allowing for all credits, the sum of Seven Thousand Dollars, \$7000,00, for which, with interest, the Claimant claims a lien on said land and improvements and on the moneys and other consideration due or to become due from the Owner under said contract..
