FOURTH AMENDMENT TO REGULATORY AND OPERATING AGREEMENT FOR OLD TOWN VILLAGE EAST, PHASE I

THIS FOURTH AMENDMENT TO REGULATORY AND **OPERATING** AGREEMENT ("Fourth Amendment") is entered into and effective as of December 27, 2004, by and between the Cinicaro Housing Authority (the "Authority"), an Illinois municipal corporation, with offices at 626 Wes Jackson Boulevard, Chicago, Illinois 60661, and Southwest Old Town Development Associates, I.L.C., an Illinois limited liability company (the "Owner"). Capitalized terms not otherwise defined herein shall have the meaning set forth in that certain Regulatory and Operating dated effective as of August 29, 2003 and recorded in the Recorder's Office of Cook County on Augus 2) 2003 as document no. 0324119211, as amended by the First Amendment to Regulatory and Operating Agreement dated September 26, 2003 and recorded September 26, 2003 in the Recorder's Office of Cook County as document number 0326931122, as amended by the Second Amendment to Regulatory and Operating Agreement dated November 4, 2003 and recorded November 4, 2003 in the Recorder's Office of Cook County as document number 0330819098, and as amended by the Third Amendment to Regulatory and Operating Agreement dated September 24, 2004 and recorded September 24, 2004 in the Recorder's Office of Cook County as document number 0426839072 (as amended hereby, the "Amended Regulatory Agreement").

WITNESSETH

WHEREAS, Authority and the Owner have previously executed and recorded the Regulatory and Operating Agreement, which encumbers certain public housing voits (the "CHA Condominium Units") described in Exhibit B thereto with certain low-income public housing requirements and imposes certain other obligations upon the Borrower; and

WHEREAS, the Owner has converted a portion of the Development, as defined in the Amended Regulatory Agreement, to a condominium form of ownership which includes certain CHA Condominium Units together with their undivided interest in the Development and all common elements and limited common elements; and

WHEREAS, the Authority and Owner desire to amend Exhibit B to the Amended Regulatory Agreement to reflect the current status of the CHA Condominium Units and all other real, personal and intangible property owned by Owner that is now subject to encumbrance and obligations of the Amended Regulatory Agreement;

NOW, THEREFORE, in consideration of the mutual promises and covenants hereinafter set forth, and of other valuable consideration, the Owner and the Authority each agree as follows:

SECTION 1. AMENDMENT OF EXHIBIT B. Exhibit B to the Amended Regulatory Agreement is hereby amended and restated to read as set forth in Exhibit B to this Fourth Amendment.

SECTION 2. FULL FORCE AND EFFECT. Except as amended by this Fourth Amendment, the terms of the Amended Regulatory and Operating Agreement remain in full force and effect, and are incorporated herein by reference as though fully set forth herein.

SECTION 3. COUNTERPARTS. This Fourth Amendment may be executed in multiple counterparts, each of which shall be an original, but all of which together shall constitute but one in the same agreement.
