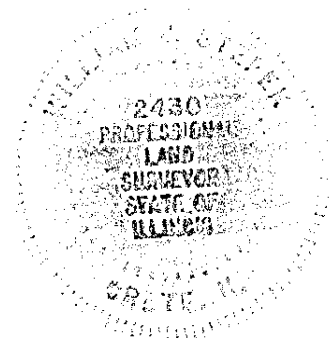
BUTTERFIELD PLACE UNIT THREE, BEING A SUBDIVISION OF PART OF THE WEST HALF OF THE NORTHWEST QUARTER AND PART OF THE NORTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 13, TOWNSHIP 35 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED AS DOCUMENT NO. 0319145018, IN COOK COUNTY, ILLINOIS.

2. TECH 3 INADVERTENTLY MADE SEVERAL ERRORS AND HEREBY CORRECTS SAME BY AMENDING THE PLAT FOR THE BUTTERFIELD PLACE UNIT THREE SUBDIVISION (DOCUMENT NO. 0319145018) AS FOLLOWS:
 - A. THE DIMENSION FOR THE WEST LINE OF LOT 138 ALONG CUCERO AVENUE WAS OMITTED AND SHALL READ 235.59 FEET.
 - B. THE DIMENSION FOR THE EAST LINE OF LOT 138 READS 427.13 FEET, AND SHALL BE CORRECTED TO READ N 32°-08'-11" E 427.20 FEET.
 - C. THE DIMENSION FOR THE NORTH LINE OF LOT 23 READS 135.48 FEET, AND SHALL BE CORRECTED TO READ 135.28 FEET.
 - D. THE DIMENSION FOR THE NORTH LINE OF LOT 22 READS 124.84 FEET, AND SHALL BE CORRECTED TO READ 124.75 FEET.
 - E. THE CURVE DATA FOR THE CENTERLINE OF HOMELAND ROAD AT THE INTERSECTION WITH CARRICK ROAD READS $\Delta = 19^{\circ}-00'-00''$ BOTH NORTH AND SOUTH OF THE INTERSECTION, AND SHALL BE CORRECTED TO READ $\Delta = 30^{\circ}-00'-00''$ FOR BOTH CURVES.
3. THE ABOVE ITEMS HEREBY BEING ALL OF THE CORRECTIONS REQUIRED TO THE BUTTERFIELD PLACE UNIT THREE SUBDIVISION (DOCUMENT NO. 0319145018).
