
WHEREAS, the aforesaid charges, together with interest, fees, and related expenses incurred by said Village has been paid in full.

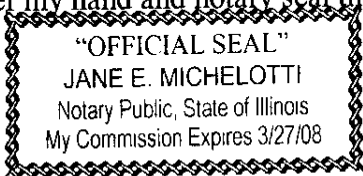


