Re: G&D Excavating, Inc. v. Mikhail Lovfman; Claim for Mechanics Lien

Dear Mr. Dienstag:

Please be advised that Mikhail Loyfman has asked that I assist him in resolving the above-referenced mechanics lien claim. I am presently in possession of a copy of a mechanics lien filed by your office with the Cook County Recorder of Deeds as Document No. 0406431036.

I have spoken with Mr. Loyfman in detail regarding this matter, and he disputes the validity of the lien, and considers it a slander of title. To begin, Mr. Loyfman denies ever receiving, let alone signing, the proposal attached as Exhibit B to the lien. Rather, Mr. Loyfman explains that he had an oral agreement with Mr. Antoniou regarding the excavation project that bears absolutely no resemblance to this written proposal. Specifically, Mr. Loyfman agreed to arrange for Mr. Antoniou to obtain \$800,000 in mortgage financing for an unrelated property at a favorable interest rate. In consideration for that service, Mr. Antoniou agreed to provide Mr. Loyfman with \$100,000 worth of excavation work free of charge.

Please also note that Mr. Loyfman advanced your client more than \$10,000 for materials and supplies, and further made a personal loan to your client in the amount of \$24,021. This amount has not yet been repaid. The subject mechanics lien is also inaccurate in that no work was performed at the 70 Harbor Court property by G&D Excavating. Finally, my client was substantially damaged by more than four months delay caused G&D Excavating, which ultimately abandoned the excavation project. As a result, Mr. Loyfman was required to hire another contractor to complete the excavation.
