WHEREAS, the Declarant now desires to so annex and add to said Procel and Property and submit to the provisions of the Act and the Declaration certain real estate set forth in Exhibit E of the Declaration (Additional Property), which after adding said Additional Property results in the Property described in Exhibit A attached hereto, which is the total of all Property being submitted to the Act and to the Declaration, as hereby amended;

NOW THEREFORE, the Declarant does hereby amend the Declaration as follows:

- 1. The Additional Property is hereby annexed to the Parcel and Property, as defined in the Declaration, and is hereby submitted to the provisions of the Act as a part of the Condominium in accordance with, and deemed to be governed in all respects by, the terms and provisions of the Declaration.
- 2. Exhibit A of the Declaration is hereby amended by deleting said Exhibit A and substituting therefore Exhibit A attached hereto.
- 3. Exhibit B of the Declaration is hereby amended by deleting said Exhibit B and substituting therefore Exhibit B attached hereto. As set forth in Paragraph 28 of the Declaration, the
