FIRST AMENDMENT TO DECLARATION OF CONDOMINIUM PURSUANT TO THE CONDOMINIUM PROPERTY ACT 4904-06 SOUTH INDIANA CONDOMINIUM

This First Amendment to Declaration of Condominium made and entered into this ______ day of January, 2005 by MAREK SOKOLOWSKI and EDWARD OLEJNICZAK (hereinafter referred to as "the Developers").

WHEREAS, the Developers are the owners of the property legally described on Exhibit A attached hereto; and

WHEPEAS, on December 15, 2004, the Developers recorded a Declaration of Condominium pursuant to the Condominium Property Act with the Cook County Recorder of Deeds as Document 0435039025, creating the 4904-06 SOUTH INDIANA CONDOMINIUM (hereinafter referred to as "the Condominium"); and

WHEREAS, the Condominium consists of six (6) Units and twelve (12) Parking Spaces, as indicated on Exhibit B and D to the Declaration of Condominium; and

WHEREAS, pursuant to Paragraph 4-(b) of the Declaration of Condominium, the Developers have assigned the Parking Spaces to certain Units, which assignment of Parking Spaces is indicated on Exhibits B and D to the Declaration of Condominium; and

WHEREAS, pursuant to Section 4-(b; of the Declaration of Condominium, before the conveyance by the Developers of the particular Unit involved, the Developers shall have the authority, without joinder or consent of any other party, to make any amendments to the Declaration necessary to re-allocate and reassign the Parking Spaces therecofore assigned to such Units; and

WHEREAS, the Developers have not yet conveyed Units 4904-2, 4904-3, 4906-2 and 4906-3, and the developers now desire to amend the Declaration of Condominium to reassign the Parking Spaces to the aforementioned Units.

NOW THEREFORE, the Developers hereby amend the Declaration of Condominium as follows:

l. Exhibit B and Exhibit D to the Declaration of Condominium of 4904-06 South Indiana Condominium are hereby amended to re-allocate the Parking Space Limited Common Elements, as follows:
