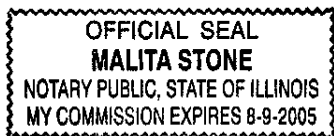

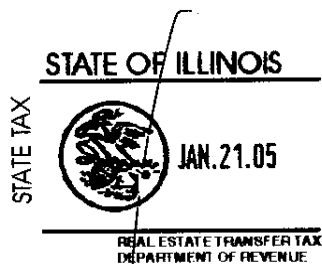

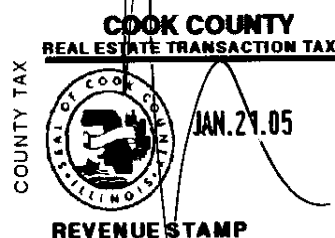
### Permitted Encumbrances
