and other good and valuable considerations in hand, paid, Convey(s) and Warrant(s) unto the **PALOS BANK AND TRUST COMPANY**, an

Illinois Banking Corporation of the United States of America, as Trustee under the provisions of a Trust Agreement dated the 4th day of December, 2001 and known as Trust Number 1-5248 the following described real estate in the County of Cook in the State of Illinois, to wit:

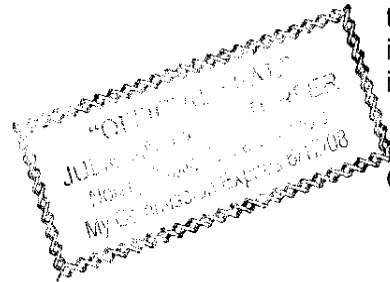

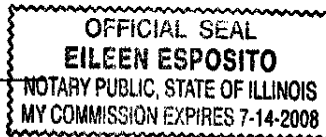
