FIRST AMENDMENT 16 ACCESS AND SIGNAGE EASEMENT AGREEMENT

THIS FIRST AMENDMENT TO ACCESS AND SIGNAGE EASEMENT AGREEMENT (this "Amendment") is made as of the 25" day of January, 2005, by and between TARGET CORPORATION, a Minnesota corporation ("Target") and DAMEN DEVELOPMENT, L.L.C., an Illinois limited liability company ("Damen").

WHEREAS, Target and Damen entered into that certain Access and Sigrage Easement Agreement dated as of August 25, 2004 and recorded on September 15, 2004 as Document Number 0425902282 with the Cook County, Illinois Recorder of Deeds (the "Agreement") for (i) the grant and conveyance of an easement by Target to Damen for vehicular and pedestrian ingress and egress over, upon and across a portion of the Target Tract, which easement area is identified as the "Access Easement Area" on the Site Plan attached as Exhibit C to the Agreement, and (ii) the grant and conveyance of an easement by Damen to Target for a monument sign over, upon and across a portion of the Damen Tract, which easement area is identified as the "Target Sign Area" on the Site Plan attached as Exhibit C to the Agreement;
