Lender may return any payment or partial payment if the payment or partial payments are insufficient to bring the Loan current. Lender may accept any payment or partial payment insufficient to bring the Loan current, without waiver of any rights hereunder or prejudice to its rights to refuse such payment or partial payments in the future, but Lender is not obligated to apply such payments at the time such payments are accepted. If each Periodic Payment is applied as of its scheduled due date, then Lender need not pay interest on unapplied funds. If the Rents of the Property are not sufficient to cover the costs of taking control of and managing the Property and of collecting the Kents any funds expended by Lender for such purposes shall become indebtedness of Borrower to Lender secured by 10° Security Instrument pursuant to Section 9. Borrower represents and warrants that Borrower has not executed any prior as seenment of the Rents and has not performed, and will not perform, any act that would prevent Lender from exercising its rights under this paragraph.

Lender, or Lender's agents of 2 judicially appointed receiver, shall not be required to enter upon, take control of or maintain the Property before or after giving notice of default to Borrower. However, Lender, or Lender's agents or a judicially appointed receiver, may do so at any time when a default occurs. Any application of Rents shall not cure or waive any default or invalidate any other right or remedy of Lender. This assignment of Rents of the Property shall terminate when all the sums secured by the Security Instrument are paid in full.

I. CROSS-DEFAULT PROVISION. Be rewer's default or breach under any note or agreement in which Lender has an interest shall be a breach under the Security in strument and Lender may invoke any of the remedies permitted by the Security Instrument.
