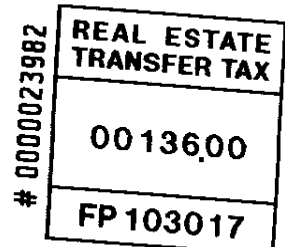
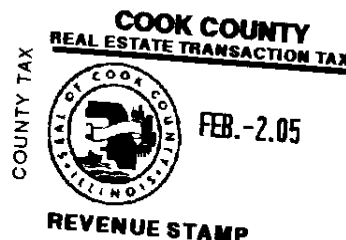
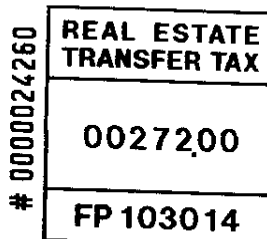
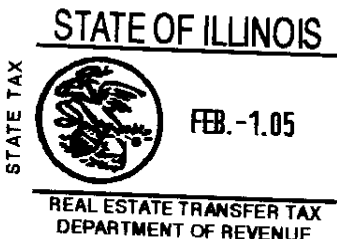
SPECIAL WARRANTY DEED

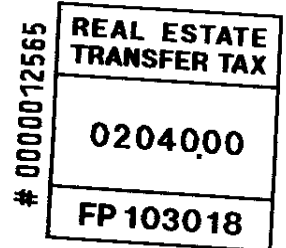
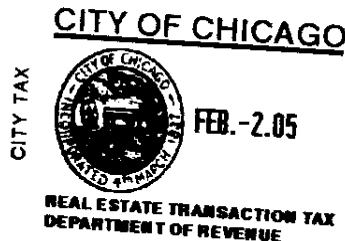
