The Contract was entered into by HSF Corporation, as the managing member of Former Owner, Former Owner's agent, c. an entity knowingly permitted by Former Owner and Current Owner to enter into contracts for the improvement of the Real Estate, and the work and additional work was performed by Claimant with the knowledge, authorization and consent of Former Owner and Current Owner. Alternatively, Former Owner authorized HSF Corporation to enter into the Contract. Alternatively, Former Owner land wingly permitted HSF Corporation to enter into the Contract for the improvement of the Real Estate. Former Owner and Current Owner knowingly permitted Claimant to perform its work and additional work.
  - 5. Claimant completed all work on the Project on February 3, 2005.

As of the date hereof, there is due, unpaid, and owing to Claimant, after allowing all credits, the principal sum of \$13,250.00, which principal amount bears interest at the statutory rate of 10 percent per annum.
