

This matter came before the Court on the motion of Defendants/Counter-Plaintiffs Illinois District Council No. 1 of the International Union of Bricklayers and Allied Craftworkers, AFL-CIO, and Local 74 Illinois of the International Union of Bricklayers and Allied Craftworkers (together the "Union"), the Court is fully informed, and it appears that good cause exists to grant the motion and enter this order.

Therefore, IT IS ORDERED as follows:


1. To whatever extent necessary, this case is reinstated for all purposes;
2. Judgment is entered, jointly and severally, against Michael C. Roche, Vera Roche, and Firacha Construction, Inc. (including throughout this order the alternate spellings under which it has operated), and in favor of the Union in the amount of \$128,010.00, along with interest at the rate of 6% a year from January 9, 2005, to the date of payment;

3. Judgment is entered against Michael C. Roche, Vera Roche, and Firacha Construction, Inc., and in favor of the Union in the additional amount of \$997.50, to reimburse legal fees and costs related to presenting the motion, and Michael C. Roche, Vera Roche, and Firacha Construction, Inc., are further liable for all reasonable legal fees and costs incurred by the Union in enforcing this order and collecting on the judgment; and

4. Michael C. Roche, Vera Roche, and Firacha Construction, Inc., must pay \$2,200.00 to Arbitrator Harvey A. Nathan.
