This cause coming on to be heard for status pursuant to the Order granting Summary Judgment on Count II of the Amended Complaint For Foreclosure Of Mortgage in favor of the Plaintiff, Thrivent Financial For Lutherans (Plaintiff), and against the Defendant, Michael Goldstein (Defendant), entered on January 27, 2005, and the Plaintiff's Petition for Attorneys Fees and Costs With Respect to Count II of the Amended Complaint (Petition), due notice having been given, and the Court being fully advised in the premises:

IT IS HEREBY ORDERED that Judgment is hereby entered in favor of the Plaintiff, and against the Defendant, in the sum of \$227,630.41 computed as follows: The amount of \$237,509.03 (as requested in Plaintiff's Motion for Summary Judgment), less a credit for the balance remaining in the Receiver's account in the amount of \$21,615.47 as identified in the Receiver's Final Report, plus attorney's fees and costs in the amount of \$11,736.85 awarded pursuant to the Petition without objection by the Defendant, with execution to issue.

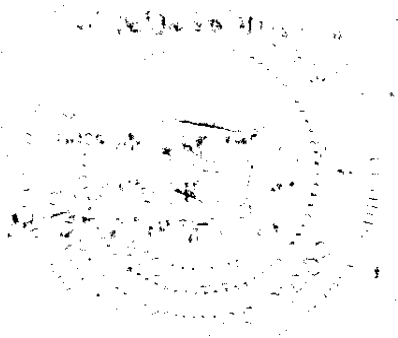
The Court finds that there is no just reason for delaying the enforcement of or appeal from this Order.


