SPECIAL WARRANTY DEED

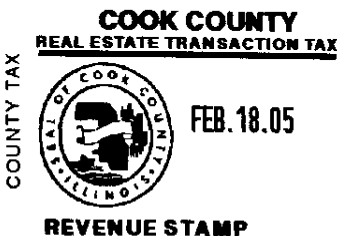
