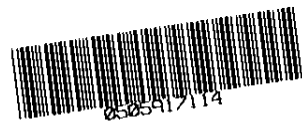



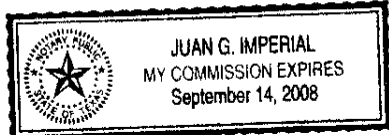

Legal Description

All that certain parcel of land situate in the County of Cook and State of Illinois being known and designated as the Southeasterly 45 36 feet of the Northeasterly 17.82 feet of the Southwesterly 20.38 feet of Lots 7, 8 and 9 taken as a tract in Block 4, in George M.
