MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated February 7, 2005, is made and executed between Christopher Bambulas and Daniela Bambulas (referred to below as "Grantor") and American Chartered Bank, whose address is 1199 E. Higgins Rd., Schaumburg, IL 60173 (referred to below as "Lender").

MODIFICATION. Lender and Grantor hereby modify the Mortgage as follows:

1). The principal amount of the Mortgage and underlying Note is herein increased from \$150,000.00 to \$200,000.00

At no time shall the principal amount of Indebtedness secured by the Mortgage, not including sums advanced to protect the security of the Mortgage, exceed \$200,000.00

2). This mortgage secures the promissory note dated December 22, 2003, in the original principal amount of \$60,000.00, from Borrower to Lender, as increased to a new principal amount of \$100,000.00 by

Change in Terms Agreement dated February 23, 2004, from Borrower to Lender, as increased to a new principal amount of \$150,000.00 by Change in Terms Agreement dated August 6, 2004, together with all renewals of, extensions of, modifications of, refinancings of, consolidations of, and substitutions for the Promissory Note.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and enforceable in accordance with their respective terms. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Mortgage (the "Note"). It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification, but also to all such sub-equent actions.
