

**AGREED ORDER - CONSENT JUDGMENT**

This cause coming before this Court for hearing on DOUGLAS W. SMITH's Petition for Attorney's Fees, the parties having reached an agreement and this matter having been heard as an uncontested matter, the Respondent, LEE M. JOHNSON II, and his former attorney, DOUGLAS W. SMITH, having entered into a negotiated settlement for attorney's fees and costs incurred, said fees pertaining only to the Respondent for representation in this cause of action. Respondent having entered into a written retainer agreement which includes the Statement of Client's Rights and Responsibilities; the Respondent being advised that he has the right to hire an attorney to represent him in a hearing on the issue of attorney's fees and costs, the Respondent understanding that he can seek to have the issue of attorney's fees and costs sent to mediation or arbitration at the Center for Conflict Resolution and opting out of said procedures; LEE M. JOHNSON II hereby waives any possible or alleged conflict of interest based upon the fact that DOUGLAS W. SMITH previously represented him in this cause of action, AND IT BEING AGREED BETWEEN LEE M. JOHNSON II and DOUGLAS W. SMITH.

**IT IS HEREBY ORDERED:**

1. A judgment is entered in favor of DOUGLAS W. SMITH and against LEE M. JOHNSON II in the amount of **\$ 3,028.50.**
2. That this sum is a negotiated settlement and it is agreed that all legal fees and costs incurred to date in this cause of action were reasonable and necessary.

## AGREED ORDER - CONSENT JUDGMENT

3. That LEE M. JOHNSON II has agreed that he will pay DOUGLAS W. SMITH TWO HUNDRED DOLLARS (\$200.00) per month the first monthly payment commencing within thirty days from the entry of this agreed order. LEE M. JOHNSON II understands that if he is more than ten (10) days late in the payment of any \$200.00 monthly payment that the full balance owed shall become due and owing and that LEE M. 5. That this consent judgment shall accrue interest at the rate of nine percent (9%) per annum.
