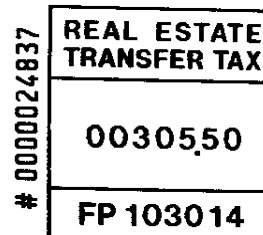
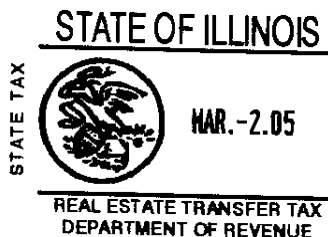
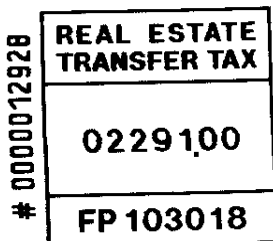
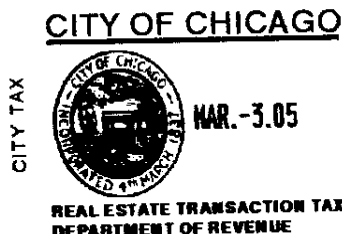
## SPECIAL WARRANTY DEED

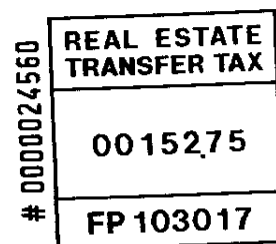
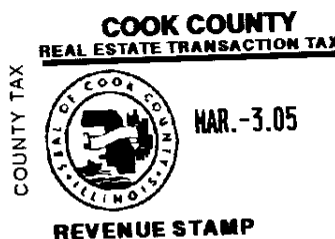

- (e) The Illinois Condominium Property Act;
- (f) Applicable zoning and building laws and ordinances;

- (j) Plats of dedication and covenants thereof; and
