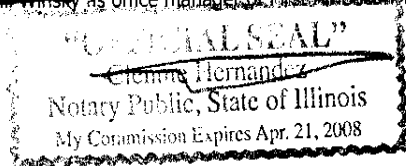

PART A - LEGAL DESCRIPTION

Parcel 1:
