

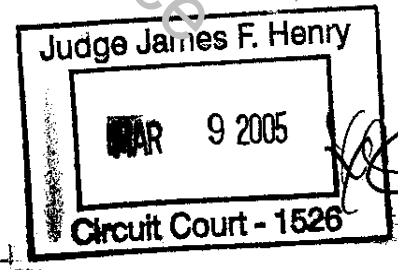
It is hereby ordered
