- (j) Plats of dedication and covenants thereof; and

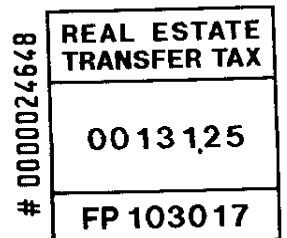
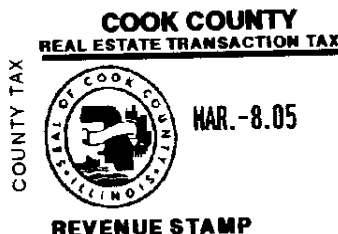
