Financial") to North Suburban on or about April 1, 2003 and evidenced by that certain Promissory Note dated April 1, 2003 and executed by North Suburban in the original principal amount of One Million Five Hundred Thousand Dollars (\$1,500,000.00) (the "\$1.5M Note");

WHEREAS, the Property is also subject to that certain mortgage deted April 1, 2003 and recorded with the Cook County Recorder of Deeds as document number 0311910095 (the "\$250K Mortgage") granted by North Suburban in connection with that certain \$250,000.00 loan ("Revolving Loan") made by M.B. Financial to North Suburban on or about April 1, 2003 and evidenced by that certain Promissory Note dated April 1, 2003 and executed by North Suburban in the original principal amount of Two Hundred Fifty Thousand Dollars (\$250,000.00) (the "\$250K Note");

WHEREAS, the Mortgage Loan and the Revolving Loan are hereinafter referred to as the "Loans", the \$1.5M Note and the \$250K Note are hereinafter referred to as the "Notes", the \$1.5M Mortgage and the \$250K Mortgage are hereinafter referred to as the

"Mortgages", and the Notes and Mortgages together with all other related agreements and documents are hereinafter referred to as the "Loan Documents";

Financial assigned to Covenant Home, the Notes, the Mortgages, and all of the other Loan Documents, including, without limitation, all of M.B. Financial's rights under the Loan Documents;

WHEREAS, North Suburban and Covenant Home have entered into a certain Forbearance Agreement of even date herewith (the "Forbearance Agreement") with respect to the Coans, subject to the terms of which Covenant Home will forbear exercising certain of its rights under the Loan Documents; and

WHEREAS, under the Forbearance Agreement, North Suburban has agreed to waive its rights reinstatement and redemption with respect to the Mortgages.

NOW, THEREFORE, in consideration of the above Recitals which are hereby incorporated by reference and other good an valuable consideration the receipt and sufficiency of which is hereby acknowledged, NORTH SUBURBAN does hereby, on behalf of itself, its legal representatives, successors, and assigns, and of its own accord, freely, voluntarily, and without duress, waive and relinquish any and all rights of reinstatement and redemption with respect to the Mongages or the liens thereof, arising under Illinois Code Chapter 735 Sections 5/15-1602 and 5/15-1603 respectively, and any and all rights of reinstatement and redemption with respect to the Montgages or the liens thereof, arising under common law or at equity.
