

This Reaffirmation of Reverter Agreement is entered into as of

Whereas, Grantee with its affiliate (wedish Covenant Hospital gave the Property Described at Exhibit A (the "Property") by quit claim deed dated December 50. 1964 recorded as document number 19555806 to Grantor;

Whereas, Grantee with Swedish Covenant Hospital retained a right of reverter in said quit claim deed; and,

Whereas, Grantor and Grantee wish to reaffirm, renew and amend this right of reverter to Grantee;

Now Therefore, in consideration of Ten Dollars and other good and valuable consideration, Grantor and its successors and assigns, hereby grants, reaffirms, renews and amends said reverter to Grantee and its successors and assigns as follows:

In the event (i) the Grantor fails to remain open to the public and activary conducting business as a YMCA, (ii) the Grantor is no longer a member of the National Council of Young Men's Christian Associations of the United States of America at the Property, (iii) the Grantor fails to use the Property exclusively as a YMCA, or (iv) the Grantor transfers the Property, the Property shall revert and vest immediately to Grantee.
