SPECIAL WARRANTY DEED

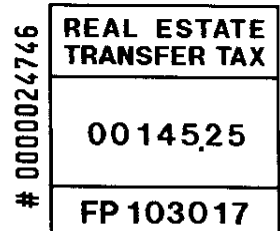
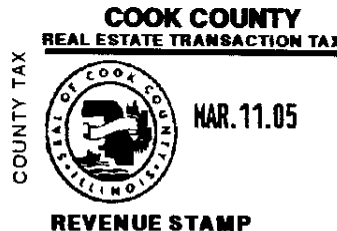
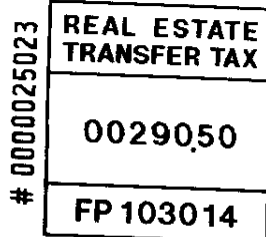
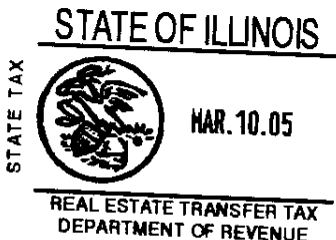
