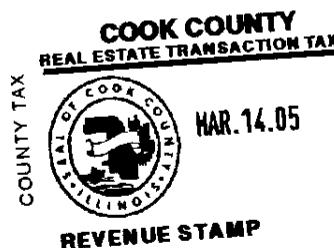
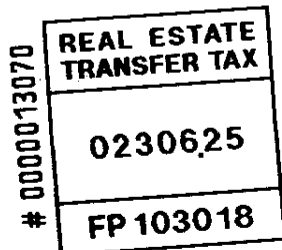
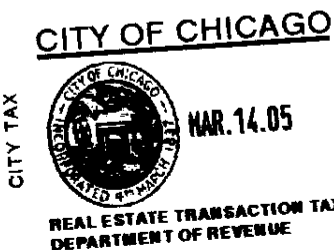
SPECIAL WARRANTY DEED

(c) Easements, covenants, restrictions, agreements, conditions and building lines of record and party wall rights;

(e) The Illinois Condominium Property Act;

(f) Applicable zoning and building laws and ordinances;
