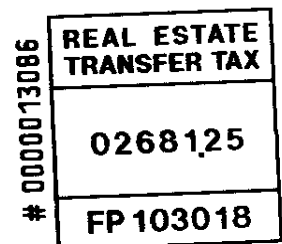
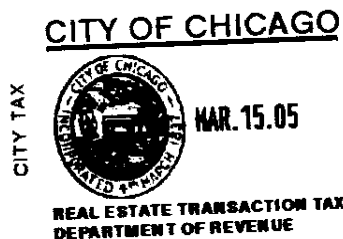
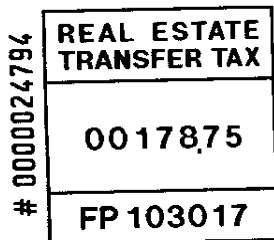
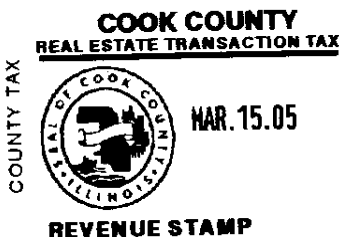
## SPECIAL WARRANTY DEED

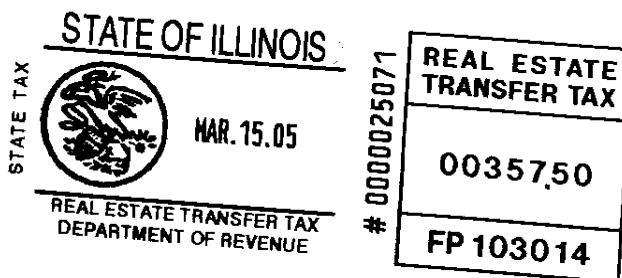
