MODIFICATION AND EXTENSION AGREEMENT

THIS ACREEMENT made as of this 1st day of March, 2005 between REPUBLIC BANK OF CHICAGO, an Illinois banking corporation, hereinafter called Bank, and North Star Trust Company as successor trustee to Republic Bank of Chicago, not personally but as Trustee under a certain Trust Agreement dated August 10, 1995 and known as Trust Number 1349, Joliet Kitchens and Baths, Inc., an Illinois corporation, and James Denos, the Owners of the property and/or the Obligors under the Note, and hereinafter both called Second Party WITNESSETH:

THAT WHEREAS, Bank is the owner of that certain Note in the amount of \$100,000.00 dated December 18, 1998, secured either in whole or in part by a Mortgage and recorded as Document No. 99019709, covering the real estate described below:

- 2. As of the date hereof, the amount of the principal indebtedness is Ninety Five Thousand Six Hundred Seventy Five and 96/100 Dollars (\$95,675.96).
- 3. This agreement is subject to Second Party paying Bank a fee of \$250.00.

Second Party warrants and certifies that the indebtedness evidenced by the Note is a valid and subsisting debt of the Obligor and in all respects free from all defenses, setoffs and counterclaims both in law and equity, as is the lien of the Mortgage.

In all other respects, the Note hereinbefore described and all mortgages, documents and/or instruments securing the same shall remain unchanged and in full force and effect.

Notwithstanding the foregoing, Second Party expressly waives any defenses, which it now has or may have or assert. Furthermore, in order to induce Bank to enter into this agreement, and or other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Second Party does hereby release, remise and forever discharge Bank of and from any and all setoffs, claims, counterclaims, demands, causes, causes of action, suits and/or judgments which it now has or may have against Bank including but not limited to matter arising out of the Note and/or any document, instrument or agreement securing the same or arising out of any banking relationship existing between the parties.
