This Memorandum of Lease ("Memorandum") is entered into on between TDC Ravinia Plaza-Orland Park, L.L.C., an Illinois limited partnership ("Landlord"), with its principal office at c/o Tucker Development Corporation, 799 Central Avenue, Suite 300, Highland Park, Illinois 60035, and Pier 1 Imports, (U.S.), Inc., a Delaware corporation ("Tenant"), with its principal office at 100 Pier 1 Place, Fort Worth, Texas 76102.

#### Landlord and Tenant hereby agree:

- 1. Lanclord's predecessor in interest and Tenant executed a Memorandum of Lease dated January 30, 1989 ("Original Memorandum"). The Original Memorandum was recorded on March 13, 1989 as Document Number 89108755 with the Cook County, Illinois Recorder's office. The Original Memorandum is terminated.
- 2. This Memorandum sets forth the basic terms of a Lease Agreement dated January 20, 1989, which was amended by a Letter Agreement dated January 19, 1989, a Lease Addendum dated July 21, 1989, a Letter Agreement dated May 22, 1992, a Letter Agreement dated August 11, 2004 and a First Amendment to Lease dated February | 14,2005 (collectively, "Lease"). Pursuant to the Lease, Landlord leases to Tenant and Tenant leases from Landlord the premises ("Premises") commonly known as 15150 South La Grange Road, Orland Park, Illinois 60462, Pier 1 Imports Store #0758, as more particularly described in the Lease. The Premises is part of a shopping center ("Shopping Center") constructed on the real property described in Exhibit A attached to this Memorandum. In addition, Landlord has granted Tenant the right to use the common areas of the Shopping Center. The Shopping Center and Premises are shown on Exhibit B attached to this Memorandum.
- 3. This Memorandum is subject to the Lease. If there is a conflict between the Lease and this Memorandum, the Lease controls.
- 4. The Lease expires on February 28, 2015, unless earlier terminated pursuant to the Lease. In addition, Tenant may extend the term of the Lease for two (2) periods of two (5) years each.




