Capitalized terms not otherwise defined herein shall have the meaning set forth in that certain Lease Agreement for Old Town Village East, Phase I dated effective as of August 29, 2003 and Memorandum of Lease ("Memorandum") recorded in the Pecorder's Office of Cook County on August 29, 2003 as document no. 0324119215, as amende in that certain First Amendment of Lease Agreement for Old Town Village East, Phase II dated affective as of December 3, 2003 and Memorandum of Lease recorded in the Recorder's Office of Cook County on December 3, 2003 as document no. 0333739146 and as amended in that certain Second Amendment of Lease Agreement for Old Town Village East, Phase II dated effective as or December 27, 2004 and Memorandum of Lease recorded in the Recorder's Office of Cook Courty on December 29, 2004 as document no. 0436416183 (together, as amended hereby, the "Amended Lease Agreement, Phase II").

WITNESSETH

WHEREAS, Authority and Owner have previously executed and recorded the Amended Lease Agreement, Phase II which encumbers certain public housing units (the "CHA Condominium Units") described in <u>Exhibit A-2</u> thereto with certain low-income public housing requirements and imposes certain other obligations upon the Owner; and

WHEREAS, the Owner has converted a portion of the Development, as defined in the Amended Lease Agreement, Phase II to a condominium form of ownership which includes certain CHA Condominium Units together with their undivided interest in the Development and all common elements and limited common elements; and

NOW, THEREFORE, in consideration of the mutual promises and covenants hereinafter set forth, and of other valuable consideration, the Owner and the Authority each agree as follows:

SECTION 1. AMENDMENT OF EXHIBIT A-2. Exhibit A-2 to the Amended Lease Agreement, Phase II is hereby amended and restated to read as set forth in Exhibit A-2 to this Third Amendment to Lease, Phase II.

SECTION 2. FULL FORCE AND EFFECT. Except as amended by this Third Amendment to Lease, Phase II the terms of the Amended Lease Agreement, Phase II remain in full force and effect, and are incorporated herein by reference as though fully set forth herein.

SECTION 3. COUNTERPARTS. This Third Amendment to Lease Agreement, Phase II may be executed in multiple counterparts, each of which shall be an original, but all of which together shall constitute but one in the same agreement.
