Legal Description

PARCEL 1:

All of the northwest ¼ of Section 27, Township 35 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois;

LESS AND EXCEPT THEREFROM:

- (III) The following tract and any portion of said northwest 1/4 lying north of the following tract:
