ASSUMPTION AGREEMENT ("ASSUMPTION")

FURTHER, Cornerstone Community hereby agrees to keep and perform all covenants and conditions on the part of the mortgagor to be kept and performed, according to the provisions of the Mortgage and the Note thereby secured, with the same effect as though it were the original maker of the Note and the original grantor of the Mortgage; and

FURTHER, subject to the terms and conditions set forth in this Assumption, NCP hereby consents to the assumption by Cornerstone Community of all of the obligations of Jesus People USA under the Mortgage and Note, provided, however, that NCP's consent under this Assumption shall not be construed as a consent to any subsequent transfer of the Property or any subsequent assumption of the Mortgage or the Note. In reliance on Cornerstone Community's covenants and agreements under this Assumption, NCP releases Jesus People USA from all of its liabilities and obligations under the Mortgage and the Note; and

FURTHER, this document may be executed in any number of counterparts, each of which shall be deemed an original and all of which shall constitute one instrument with the same effect as if all parties had signed the same signature page.
