Anne Bleecker being duly sworn, deposes and says under the penalty of perjury,

1. I am the Assistant Vice President for Residential Funding Corporation, the last holder of a certain Note dated **November 5, 1998** made by **Ola Roudez** payable to the order of **Creative Mortgage** in the original amount of **\$110,500.00**.
2. The said Note was secured by a **Mortgage or Deed of Trust**, which **Mortgage or Deed of Trust**, executed by Grant Mortgage Services, Inc. and was recorded on **November 16, 1998** in **Book --**, on **Page --** as **Instrument No. 08-029478** in the Office of the Recorder of **Cook County, State of Illinois**.
3. **Residential Funding Corporation** was the last holder of the Note as evidenced by the chain of endorsements set forth on the said Note. A true and correct copy of the Note is attached hereto and incorporated herein by reference. Residential Funding Corporation had been the holder of the Note and had been in physical possession of all associated loan records since the loan transferred to us in **February, 1999**.

Based upon the information available to us, it appears the Assignment of the **Mortgage or Deed of Trust** from **Creative Mortgage** to **Walsh Securities, Inc.** and from **Walsh Securities, Inc.** to **Residential Funding Corporation** was either lost prior to recording or inadvertently not prepared when the loan transferred from Creative Mortgage to Walsh Securities, Inc. in January of 1999 and then from Walsh Securities, Inc. to Residential Funding Corporation in February of 1999, and is not now obtainable.
