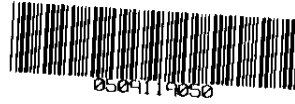

That part of Lot 3 in Coy's re-subdivision of Lots 8, 9, 10, 11 and 12 of Block 2 in "Glencoe" described as follows:

Beginning at a point in the Easterly line of said Lot 3, 255.31 feet Northerly of the Southeasterly corner of said Lot 3; thence Westerly at right angles to said Easterly line of Lot 3, a distance of 38.0 feet; thence Southwesterly 40.75 feet to a point on a line 75.0 feet Westerly of and parallel with the Easterly line of said Lot 3; thence Southwesterly 215.13 feet to a point in the Southwesterly line of Lot 3 (being also the Northeast line of Greenleaf Avenue) chord measurement 55.50 Southeasterly of the North Westerly corner of said Lot 3; thence Northwesterly along said Southwesterly line of Lot 3 55.50 feet chord to the Northwesterly corner of said Lot 3; thence Northeasterly along the Northwesterly line of said Lot 3 to the Northeasterly corner of said lot; thence Southerly along the Easterly line of said Lot 3, 82.69 feet to the point of beginning.

Also -- all that part of Lot 13 in Block 2, Glencoe, in the North West 1/4 of Section 8, Township 42 North, Range 13, lying East of the Third Principal Meridian, described as follows: beginning at a point in the Westerly line of said Lot 13, 110 feet Southerly from the Northwesterly corner of said Lot 13, as measured along the Easterly line of Greenleaf Avenue; thence Southerly along the Southwesterly line of said Lot 13 a distance of 32.6 feet to the Southwesterly corner of said Lot 13; thence Northeasterly along the Southeasterly line of said Lot 13 a distance of 176.5 feet to a point on said Southeasterly line and thence Southwesterly in a straight line a distance of 168.18 feet to the point of beginning.
