## ARTICLES OF INCORPORATION

2001 Fargo Inc.

Article 4.

Paragraph 2:

No shareholder shall transfer any share held by him or her unless said shareholder first offers the share in writing for sale to each of said other shareholders at the same price and at the same terms as said shareholder would obtain on a transfer to a non-shareholder. The writing shall contain the price and terms of the offer and be sent by registered mail to each shareholder at the last address shown on the corporation's records. The shares shall not be transferred to a non-shareholder unless and until all existing shareholders refuse the offer or fail for a period of thirty (30) days after receipt of the written offer to accept the same by compliance with the terms of the offer.
