In the event of the resignation, demise or inability of JEFFREY B. SCHONER to act, then LYNN K. PCWEP, shall act as successor trustee. In the event of the resignation, demise or inability of LYNN K. POWER to act, then DENIS J. OWENS shall act as successor trustee.

The phrase "inability to act" as used herein shall be defined as follows: Any individual acting it a fiduciary capacity or as a beneficiary of the trust shall be considered unable to act if adjudicated incompetent or if a physician familiar with his or her physical and mental condition certifies in writing that such individual is unable to give prompt and intelligent consideration to business matters.
