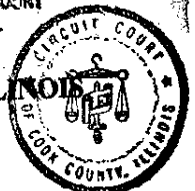

PIN: 29-11-411-056

Lot 15 (except the north 15 feet thereof) and the east $\frac{1}{2}$ of the vacated alley west and adjacent thereto and the north 25 feet of Lot 16 and the East $\frac{1}{2}$ of the vacated alley west and adjacent thereto in Sunset Ridge, being a subdivision of Lots 1 through 8 in Block 5 in Pohler's Subdivision of the Southeast $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ of Section 11, Township 36 North, Range 14 and that part of the Northeast $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ beginning at the Southeast corner of the Northeast $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ of said section, thence North 545.6 feet to the center of Michigan City Road, thence Northwesterly 834.6 feet, thence South 1047.98 feet to the North line of the Southeast $\frac{1}{4}$ of the Southeast $\frac{1}{4}$, thence East to the place of beginning, in Cook County, Illinois.
