TO THE HONORABLE JUDGE OF SAID COURT:

Your Petitioner, City of Evanston, an Illinois Municipal Corporation, respectfully shows that theretofore, to-wit: on the 28th day of March, 2005, the City Council of said City of Evanston did pass an Ordinance, which was approved by the Mayor of said City of Evanston, on the 29th day of March, 2005, providing that a local improvement be made, namely:

That the unimproved public alley in the block bounded by Central Street on the north, Harrison Street on the south, Elm Avenue on the west, and Pioneer Road on the east, in the City of Evanston, be improved by excavating, constructing the necessary drainage system and paving with 8" Portland Cement Concrete Pavement to a width of eleven and one-half feet (11-1/2').

as provided in said Ordinance, a copy of which said Ordinance certified by the City Clerk under the corporate seal of said City of Evanston, and also a copy of the Recommendations of the Board of Local Improvements of said City of Evanston and a copy of the Estimate of the cost of said improvement, as approved by said Council, are hereto attached and made a part hereof.

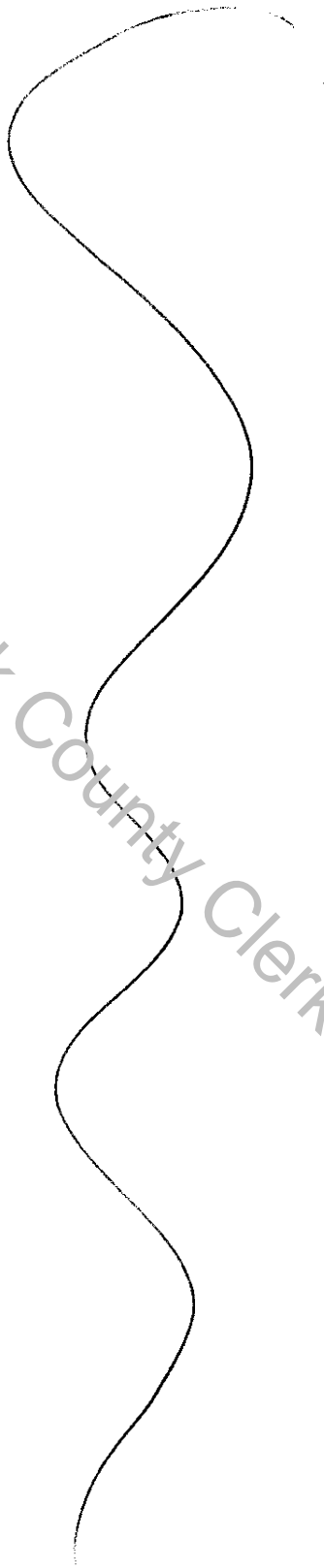
