1. Payment of Principal, Interest, Escrow Items, Prepayment Charges, and Late Charges. Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. residence for at least one year after the date of occupancy, unless Lender otherwise agrees in writing, which consent shall not be unreasonably withheld, or unless extenuating circumstances exist which are beyond Borrower's control.

7. Preservation, Maintenance and Protection of the Property; Inspections. Borrower shall not destroy. damage or impair the Property, allow the Property to deteriorate or commit waste on the Property. shall continue to pay to Lender the amount of the separately designated payments that were due when the insurance coverage ceased to be in effect. jurisdiction where the Property is located that relate to health, safety or environmental protection; (c) "Environmental Cleanup" includes any response action, remedial action, or removal action, as defined in Environmental Law; and (d) an "Environmental Condition" means a condition that can cause, contribute to, or otherwise trigger an Environmental Cleanup.

Transfer of the Property or a Beneficial Interest in Borrower.
