AMENDMENT NO. 1 TO MORTGAGE -CHARLES PAGE

This Amendment No. 1 to Mortgage is dated as of April 21, 2005, and is made by THE NORTHERN TRUST COMPANY, not personally but as Trustee inder trust agreement dated June 16, 1986 and known as Trust #8013 ("Mortgagor") in favor of THE NORTHERN TRUST COMPANY ("Mortgagee"). This Amendment pertains to the real estate described on Exhibit A attached hereto and made a part hereof.

PREAMELE:

Mortgagor has requested Mortgager to modify Mortgagee's existing financing of Mortgagor. Mortgagee has agreed to do so, so long as, ar ong other things, Mortgagor executes and delivers to Mortgagee this Amendment.

NOW, THEREFORE, in consideration of the premises which are incorporated herein by this reference and constitute an integral part hereof and the execution and delivery of this Amendment, Mortgagor agrees as follows:

- 1. The definition of "Loan" in the Mortgage is hereby amended to read as follows:
- "(F) "Loans" means the debt evidenced by the Notes, plus any interest, any prepayment charges and late charges under the Notes, and all sums due under this Security Instrument, plus interest."
- 2. The definition of "Note" in the Mortgage is hereby amended to read as follows:

"Notes. The word "Note" means individually and the word "Notes" means together each of (a) that certain Balloon Note dated January 13, 2004 in the original principal amount of \$1,400,000.00 given by Mortgagor and Charles L. Page ("Page") to Mortgagee as may be renewed, replaced, extended, modified, substituted or amended form time to time; and (b) that certain Master Note dated October 1, 2004 in the original principal amount of \$50,000.00 given by Page to Mortgagee as may be renewed, replaced, extended, modified, substituted or amended form time to time; and (c) that certain Master Note dated October 1, 2004 in the original principal amount of \$2,842,064.00 given by Page to Mortgagee as may be renewed, replaced, extended,

modified, substituted or amended form time to time; and (d) that certain Application and Agreement for Irrevocable Letter of Credit executed by Page in favor of Mortgagee relating to the issuance of that certain Irrevocable Standby Letter of Credit in the amount of \$700,000.00, as may be renewed, replaced, extended, modified, substituted or amended form time to time. The interest rates contained in the Notes may be variable rates of interest based upon an index. If the index increases, the payments tied to the index, and therefore, the total amount secured hereunder, will increase. NOTICE: Under no circumstances shall the interest rate on this Mortgage be more than the maximum rate allowed by applicable law."

- 3. All references to the "Mortgage" in the Mortgage shall mean the "Mortgage" as amended by this Amendment and as may be further amended and/or restated from time to time.
- 4. All references to the "Note" in the Mortgage shall mean the "Notes" as defined in the Mortgage as an ended by this Amendment and as may be further amended and/or restated from time to time.
- 5. in all other respects, the Mortgage is hereby restated, reaffirmed and incorporated herein, the only amendments intended to be made thereto being those above set forth. Except as specifically set forth herein to the contrary, all terms defined in the Mortgage shall have the same meanings herein as therein.
