ORDINANCE NO. 04-05

AN ORDINANCE AUTHORIZING 2ND REDEVELOPMENT AGREEMENT

WHEREAS, The Village of Hodgkins, a Home Rule Illinois Municipal Corporation ("Village") and Menard, Incorporated, a Wisconsin Corporation ("Menards"), have already executed a Redevelopment Agreement on July 28, 2003, and,

WHEREAS, an amendment for the Redevelopment Agreement was deemed necessary by the Village and Monards on November 26,2003, and,

WHEREAS, after a thorough study and numerous discussions with Menards, the officials of the Quarry Shopping Center, and our experts including an appraiser and Traffic Control Specialist, it is deemed necessary to alter a substantial portion of the Amended redevelopment Agreement with Menards; and,

NOW, THEREFORE, BE IT ORDAINED by the President and the Board of Trustees of the Village of Hodgkins, Cook County, Illinois, in the exercise of its statutory and home rule powers, as follows:

Section 1

That the President is authorized to execute and the Clerk is authorized to attest to his signature affirming the Village's acceptance to the terms of the Redevelopment Agreement as presented to this Board of Trustees.

Section 2

The Village shall exercise its best efforts in effectuating its obligations under this 2nd Amended Redevelopment Agreement and bring the opening of a new Menards store in Hodgkins to a successful reality.

Section 3

If any action, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity shall not affect any of the other provision of this Ordinance.

Section 4
